NEW MEMBER AWARD – JENNIFER BROWNING

The winner of the FCPA New Member Award has served as the Conference Registration Chair for FCPA's annual conference for the past two years. Next to the Conference Chair, this position is one of the most time-consuming and important positions on the conference planning committee. In addition to the obvious role of registering everyone in advance for the conference, collecting the conference fees, and managing the onsite registration process, this position entails a great deal of planning and coordination with the FCPA Information Management Director to make sure the online registration process runs smoothly.

This year, the planning and coordination also included implementing an online payment process and Jennifer played an integral role in helping to launch this new process. She spent a considerable amount of time making sure the registration and payment process would run smoothly and I think that the FCPA membership has found the end result to be easy to use and efficient. Jennifer has made a very significant contribution to FCPA in the few years that she has been involved with the organization and she exhibits the characteristics of a future FCPA leader.



STUDENT OF THE YEAR - CEDRIC NABE

This year's FCPA Student of the Year first came to Florida State University in 2004 from Geneva, Switzerland on a full scholarship for track and field. He was the team captain in 2005-06 and a two-time member of the National Championship Team in 2006 & 2007. Even though he excelled in the sport, he was also very interested in computers. At FSU, he chose Computer Information Technology as his major.

Cedric Nabe interned as an application developer for two semesters at Hospital Corporation of America (HCA). He worked closely with the company's project manager to identify the needs and requirements of an IT application that would improve the company's project management. He designed diagrams that showed how the data were going to be stored, retrieved, and managed. All of this work paved the way for the design of the Project Registry database. Cedric was asked to return to HCA for a second semester in order to complete the creation of the Registry that will serve all of the company's north Florida division.

In his spare time, Cedric has been developing the software application- SportLog- that he hopes will soon revolutionize the way coaches and student athletes interact and track their progress. Because of the project, Cedric received the Florida State University Undergraduate Research and Creative Activity Award and used the award money to conduct additional research, secure a website domain, and apply for a copyright.

Just a few of Cedric's other accomplishments include being the first in his family to obtain a college degree, he was selected to the World Junior Championship for the Swiss track and field team in high school and is currently in training and competition for this year's Olympics. He was the recipient of the Golden Torch Academic Award which is awarded to the athlete with the highest GPA. Cedric was a part of the 4x100 meter relay team that broke FSU's school record. He joined the Association of Information Technology Professionals in the fall of 2006 and has served as the president of the FSU chapter from 2007 to the present.

When Cedric was asked what was most important or valuable about his internship, he replied "teamwork. I have learned so much about knowing how to adapt myself in different situations." His response when asked why he thinks he's successful was, "I honor my commitments by working hard and never giving up on my goals."

SUMMARY OF THE 2008 ANNUAL BUSINESS MEETING

Board Reports

President's Report- Dona Gaynor reviewed this year's goals:

- FCPA has become and incorporated organization. We are still currently working on obtaining tax exempt status; this should take about 6 months to receive this recognition.
- Our new member numbers have increased this year due to the hard work of Sandy Jakubow, Membership Director, and the Membership Committee.
- After reviewing the FCPA membership categories, we have proposed and passed an amendment adding and "affiliate member" category. This will allow professionals who are not necessarily career services or recruiting to join, e.g. 3rd party recruiters, faculty members, etc. These members will not have voting privileges. We have also formalized our Graduate Student category.
- The board has revised the Student of the Year Award process to make it easier for applicants and also more competitive. We have also implemented New Member award.
- An amendment to revise several board member job titles and descriptions was proposed and passed. This revision of duties will distribute tasks more evenly among board members.

Treasurer's Report- Dona Gaynor reported that as of the business meeting, revenue was down a little this year. We have taken in approximately \$38,600 with total expenses estimated at \$36,878.50. Our reserve balance is approximately \$31,138.00 with an actual bank balance is approximately \$57,207.00. The FCPA bank account is balanced.

Secretary Report- Andrea Alfano reported that the membership numbers for 2008 are consistent with those from the previous year with a slight increase in employer members. As of the conference, there were 281 members (99 new members and 182 renewing members).

Membership Report- Sandy Jakubow reported that the membership committee recruited 99 new members this year. The committee incorporated strategies including mailing recruitment letters, targeting employers in SW Florida Region, placing outreach calls to members of the Naples Chamber of Commerce and the Ft. Myers Chamber of Commerce, and conducting phone call/email blasts. They also promoted FCPA to employers by distributing Employer Spotlight flyers to employers at the Statewide Job Fair in May.

Information Manager Report- Lindsey Katherine reported that our credit card payment implementation had been incorporated into the website. There were not as many credit card payments as anticipated, but she expects them to increase next year. The last *Connection* was the biggest in terms of articles submitted by our members. A reminder that the online database is available to members; the log in ID is "fcpa" and the password is "brownlee."

There were 107 members in attendance this year; a positive turnout considering the budget problems felt across our state. Seventy-eight college members, 25 employer representatives and 3 exhibitors gathered together for three days of fun including presentations from fantastic guest speakers, informative breakout sessions, spirited recreation events, incredible door prizes and excellent food!

CONFERENCE EVALUATIONS

The evaluation surveys are in and it's clear this year's FCPA conference was a success. We had 35 schools represented and 16 employers/organizations at this year's conference. Thanks to all of our survey participants we are happy to report an 82.5% survey response rate (85 out of 103 conference attendees). Clearly a sign that FCPA members are in it together! The feedback collected from the survey will be reviewed by the Board of Directors and Conference Committee members. It will also be passed on to Andrea Alfano as she leads next year's conference committee on planning the 2009 FCPA Conference in Orlando. Below is a summary of the survey

results.

The overall conference was rated either Excellent or Very Good by 92% of respondents (an average of 4.5 on a 5-point scale), while the beautiful Naples Grande Resort, this year's conference location, received an average rating of 4.8. The breakout sessions received an overall rating of a 4.2 with the top breakout session being the "Hiring Foreign Graduates in the U.S." with an average rating of 4.75. The next top two sessions with a 4.55 average rating: "The State Department and Federal Agencies" and "It Takes a Village: Strategic Partnerships to Enhance Student Learning in a Career Planning Class".



The meals, receptions and special events all received positive ratings. The three top-rated events were The Sunset Banquet (4.61), The President' Reception (4.45), the Opening Keynote Speaker, Mr. Phil Gardner's presentation on "Recruiting Trends" (4.15). The new Employer Spotlight initiative was very well received with an average rating of 4.07 with some commenting that this was a great idea.

Most of the survey respondents reported having met their goals for the conference, some of which included networking, learning about best practices to bring back to our campuses and catching up with old colleagues. Respondents provided a few suggestions for next year's conference, including bringing back the New Member Orientation, more networking opportunities, and adding a career panel.

The overall event was well received and many shared comments on how much they enjoyed the hotel location, how beneficial the networking was and how informative the breakout sessions were. In addition, the conference planning committee was acknowledged by various respondents for doing such a fantastic job. We look forward to seeing you at next year's conference!

FROM OUR MEMBERS

The Johnson Career Initiative Targets Students with Disabilities at Florida International University

Through a generous grant from the Theodore R. and Vivian M. Johnson Scholarship Foundation, the Career Services Office (CSO) and Disability Resource Center (DRC) in a joint venture at Florida International University (FIU) have developed the Johnson Career Initiative directed at the career planning needs of students with disabilities. This program is the first of its kind at FIU and one of the first models of collaboration in the country.

For students at FIU, this innovative collaboration between offices aims to provide seamless access to all of the resources of the CSO for students with any disability. In addition to addressing the needs of students, the Johnson Career Initiative also seeks to identify disability-friendly corporations and organizations to actively recruit at the university during semi-annual career fairs. Through the initiative, information and training will be offered to students and recruiters regarding the provision of accommodations for interviews, resumes, and career related-events.

Currently, the CSO presents a full array of career planning and job search resources including walk-in appointments with Career Coaches, resume critiques, mock interviews, employability skills and soft skills workshops, career counseling, online job searches and resume postings, career library and internship information. Through the Johnson Career Initiative each of these resources has started the process of being evaluated with regard to their accessibility and will be up-graded to insure seamless access for all students. The benefit of this work directly impacts the student population at FIU and works to ensure the best quality resources for our students. The Director of the DRC, Amanda Niguidula shared that the focus of the program is "on exploring, identifying and fostering various mechanisms that compliment and enhance the manner in which we relate to students so that all students are effectively served."

In addition to the aforementioned resources the CSO and the DRC have partnered together though

the Johnson initiative to present and promote specialized events that reach out to the student community. A workshop titled "Fact, Fiction and Faux Pas in Protocol, Etiquette and Business" featured a former protocol affairs officer from Los Angeles County, California and focused on the development of etiquette in recruiting and interviewing. The CSO and DRC again partnered with the Greater Miami Society for Human Resource Management and the Miami Dade Business Leadership Network to plan and present the "Diversity for Dollars Job Fair." A huge success, this program allowed the FIU community to showcase its commitment to student diversity through collaboration with the greater Miami-Dade community while proactively promoting employment opportunities for FIU students. Additionally, a week-long programming series was also held in the DRC and included open forums to address student needs and concerns, targeted workshops on resume writing, cover letters, interviewing skills and an overall introduction to the CSO, as well as an information session hosted by the State of Florida Department of Vocational Rehabilitation featuring assessment services. funding, and workplace accommodations. These areas of programming continue to be successful for our students while fulfilling goals of the CSO and DRC and the Johnson Career Initiative.

By incorporating the concepts of accessibility and universal design into the training of the Career Services staff, the Johnson Career Initiative provides sustainability to this effort. According to Lenroy Jones, Director of the CSO, "This sustainability component is singularly important to the Johnson project. Our aim is to provide more than one-time assistance to one student by insuring that any staff member can offer our services to any student no matter the disability." This paradigm of sustainability not only focuses on the success of the program, but focuses on the success of the individual student.

In conclusion, the CSO and DRC at FIU will continue to collaborate and develop innovative strategies that impact and provide access to all FIU students. Over the next few months, the CSO and DRC will release the 2007-2008 Johnson Career Initiative Annual Report, which will help set benchmarks and strategic planning initiatives for the upcoming year. These benchmarks will be

used to set goals and continue developing the most appropriate, seamless, and creative strategies for the students at FIU. The Johnson Program has not only created a partnership between offices it has bridged the dreams of opportunity and access for so many students at FIU.
